SBOT Women in the Profession Committee Seeks Monetary Donations and Help Compiling Information

The Women in the Profession Committee of the State Bar of Texas has recently received partial funding from the State Bar of Texas Foundation for the preparation of a treatise on the lives and careers of Texas Women Lawyers, both past and present. The Committee is seeking an additional \$18,000.00. The treatise will describe Texas women and their involvement in the legal profession as law students, attorneys, judges, and professors. At this point, the Committee is accumulating a list of "firsts" for women lawyers in Texas — first licensed in the state, first to practice in various jurisdictions, first on various courts, and accomplishments of that nature. They also intend to document the progress of Texas women lawyers from earliest times through the present. Once the book is completed, they plan to distribute it to women's organizations, law schools, high schools, and public libraries. It will also be distributed to new members of the State Bar of Texas.

While the Committee is interested in monetary contributions, it is also seeking and equally important to receive input about women from our geographical area whom you believe should be included in this historical account. This input would include not only the pioneers in our area but also those who are presently practicing who have achieved distinction in the practice of law.
